**NUNC PRO TUNC TRADEMARK ASSIGNMENT**

**THIS TRADEMARK ASSIGNMENT** (“Assignment”), effective June 2<sup>nd</sup>, 2006, is made by and between **Preventsys, Inc.**, a Delaware corporation with a place of business in the State of California (“Assignor”) and **McAfee, Inc.**, a Delaware corporation with a place of business in the State of California (“Assignee”).

**Recitals**

**WHEREAS**, Assignee is purchasing from Assignor certain assets, properties and business, including without limitation, the trademarks which are used by Assignor or which pertain to the purchased assets, properties and business of Assignor; and

**WHEREAS**, Assignor represents that it owns the entire right, title and interest in, to and under the trademarks, together with the goodwill of the business symbolized by the trademarks or to which the trademarks pertain. **WHEREAS**, Assignee is desirous of acquiring the entire right, title and interest of Assignor in and to the Trademarks along with the goodwill of the businesses symbolized by the Trademarks or to which the Trademarks pertain, and all other rights appurtenant thereto.

**NOW, THEREFORE**, for and in consideration of the mutual covenants and agreements contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign, transfer and deliver to Assignee, its successors, assigns and legal representatives, its full and exclusive right, title and interest in and to the Trademarks, together with the goodwill of the businesses symbolized by the Trademarks and associated therewith, or to which the Trademarks pertain, and all other common law rights and applications and registrations of the Trademarks, and the right to recover for damages and profits for past infringements of the Trademarks.

This assignment shall be binding upon Assignor's successors, assigns and legal representatives, and shall inure to the benefit of Assignee, its successors, assigns and legal representatives, as the case may be.

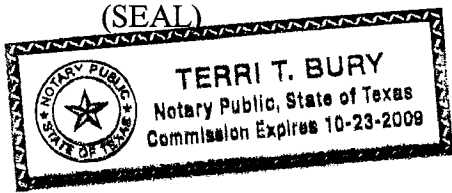
