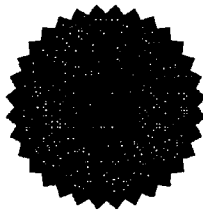

General Bandwidth Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify that:

FIRST: The name of the Corporation is General Bandwidth Inc.

SECOND: The Board of Directors of the Corporation, by the unanimous consent of its members, adopted a resolution declaring advisable that the following amendment to the Eighth Amended and Restated Certificate of Incorporation, as amended, of the Corporation be submitted to the stockholders for approval in accordance with Section 242 of the General Corporation Law of the State of Delaware.

RESOLVED, that the Board of Directors, in its best business judgment, hereby declares it advisable and in the best interests of the Corporation to, effective as of the date first written above, amend the Corporation's Amended and Restated Certificate of Incorporation to change the name of the Corporation to GENBAND Inc., and that the appropriate officers of the Corporation are directed to submit the following amendment to the Corporation's Amended and Restated Certificate of Incorporation to the stockholders of the Corporation for their consideration and approval:

Article I shall be deleted in its entirety and replaced with the following language:

"ARTICLE I

The name of this corporation is GENBAND Inc."

THIRD: The aforesaid amendment was duly adopted by the Corporation's stockholders in accordance with the applicable provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.
