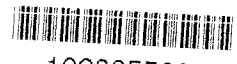



WHEREAS, United States Fidelity and Guaranty Company ("USF&G" or "Assignor"), a Maryland Corporation with a principal place of business at 6225 Centennial Way, Baltimore, Maryland 21209, was the prior owner of the trademark TITAN INSURANCE & Design, the subject of U.S. Reg. 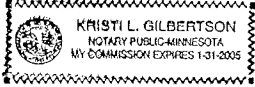
