**AMENDMENT  
TO  
COLLATERAL ASSIGNMENT, PATENT MORTGAGE  
AND SECURITY AGREEMENT**

This Amendment to Collateral Assignment, Patent Mortgage and Security Agreement is made as of June 2/1, 2004 by and between Evolutionary Technologies International, Inc. ("Assignor"), and Silicon Valley Bank, a California banking corporation ("Assignee").

**RECITALS**

A. Assignee and Assignor are parties to that certain Loan and Security Agreement dated October 24, 2000 (as amended from time to time, the "Loan Agreement") and that certain Collateral Assignment, Patent Mortgage and Security Agreement dated January 19, 2001 (the "Original IP Agreement"), which was recorded in the U.S. Copyright Office on January 30, 2001, Volume 3464, Page 879 with respect to the copyrights identified therein, and which was recorded in the U.S. Patent and Trademark Office on January 30, 2001, Reel/Frame 011483/0251 with respect to the patents identified therein and which was subsequently supplemented by that certain Supplement One to Collateral Assignment, Patent Mortgage and Security Agreement dated October 23, 2002 (the "Supplement"), which Supplement was recorded in the U.S. Copyright Office on October 30, 2002, Volume 3490, Page 889 with respect to the copyrights identified therein (the Original IP Agreement as supplemented from time to time is hereinafter referred to as the "IP Agreement"). (Capitalized terms used herein, which are not defined, shall have the meanings set forth in the IP Agreement.)

B. The parties desire to amend the IP Agreement as follows, effective as of the date hereof.

The IP Agreement, as amended hereby, shall continue in full force and effect with respect to the Collateral described therein.

**NOW, THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:**

1. **Modified Assignment, Patent Mortgage and Security Interest.** Section 1 of the IP Agreement is hereby amended and restated to read as follows:

1. **Assignment, Patent Mortgage and Grant of Security Interest.** As collateral security for the prompt and complete payment and performance of all of Assignor's present or future indebtedness, obligations and liabilities to Assignee, Assignor hereby assigns, transfers, conveys and grants a security interest and mortgage to Assignee, as security, but not as an ownership interest, in and to Assignor's entire right, title and interest in, to and under the following (all of which shall collectively be called the

"Collateral"):

(a) All of present and future United States registered copyrights and copyright registrations, including, without limitation, the registered copyrights listed in Exhibit A-1 to the Original IP Agreement, Exhibit A to the Supplement and Exhibit A to this Amendment, in each instance, effective as of the date set forth with respect to each item, (and including all of the exclusive rights afforded a copyright registrant in the United States under 17 U.S.C. §106 and any exclusive rights which may in the future arise by act of Congress or otherwise) and all present and future applications for copyright registrations (including applications for copyright registrations of derivative works and compilations) (collectively, the "Registered Copyrights"), and any and all royalties, payments, and other amounts payable to Assignor in connection with the Registered Copyrights, together with all renewals and extensions of the Registered Copyrights, the right to recover for all past, present, and future infringements of the Registered Copyrights, and all computer programs, computer databases, computer program flow diagrams, source codes, object codes and all tangible property embodying or incorporating the Registered Copyrights, and all other rights of every kind whatsoever accruing thereunder or pertaining thereto.

(b) All present and future copyrights which are not registered in the United States Copyright Office (the "Unregistered Copyrights"), whether now owned or hereafter acquired, including without limitation the Unregistered Copyrights listed in Exhibit A-2 to the Original IP Agreement and Exhibit A to this Amendment, in each instance, effective as of the date set forth with respect to each item, and any and all royalties, payments, and other amounts payable to Assignor in connection with the Unregistered Copyrights, together with all renewals and extensions of the Unregistered Copyrights, the right to recover for all past, present, and future infringements of the Unregistered Copyrights, and all computer programs, computer databases, computer program flow diagrams, source codes, object codes and all tangible property embodying or incorporating the Unregistered Copyrights, and all other rights of every kind whatsoever accruing thereunder or pertaining thereto. The Registered Copyrights and the Unregistered Copyrights collectively are referred to herein as the "Copyrights".

(c) All right, title and interest in and to any and all present and

future license agreements with respect to the Copyrights, including without limitation the license agreements listed in Exhibit A-3 to the Original IP Agreement (the "Licenses").

(d) All present and future accounts, accounts receivable and other rights to payment arising from, in connection with or relating to the Copyrights.

(e) Any and all trade secrets, and any and all intellectual property rights in computer software and computer software products now or hereafter existing, created, acquired or held;

(f) Any and all design rights which may be available to Assignor now or hereafter existing, created, acquired or held;

(g) All patents, patent applications and like protections including, without limitation, improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same, including without limitation the patents and patent applications set forth on Exhibit B attached to the Original IP Agreement and Exhibit A hereto in each instance, effective as of the date set forth with respect to each item, (collectively, the "Patents");

(h) Any trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Assignor connected with and symbolized by such trademarks, including without limitation those set forth on Exhibit C attached to the Original IP Agreement and Exhibit A hereto in each instance, effective as of the date set forth with respect to each item, (collectively, the "Trademarks");

(i) Any and all claims for damages by way of past, present and future infringements of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights identified above;

(j) All licenses or other rights to use any of the Copyrights, Patents or Trademarks, and all license fees and royalties arising from such use to the extent permitted by such license or rights;

(k) All amendments, extensions, renewals and extensions of

any of the Copyrights, Trademarks or Patents; and

(1) All proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.

**THE INTEREST IN THE COLLATERAL BEING ASSIGNED  
HEREUNDER SHALL NOT BE CONSTRUED AS A CURRENT  
ASSIGNMENT, BUT AS A CONTINGENT ASSIGNMENT TO  
SECURE ASSIGNOR'S OBLIGATIONS TO ASSIGNEE UNDER  
THE LOAN AGREEMENT.**

2. **General.** As amended hereby, all terms and conditions of the IP Agreement shall continue in full force and effect, and Assignor represents and warrants to Assignee that all representations and warranties set forth in the IP Agreement, as amended hereby, are true and correct as of the date hereof; provided, however, that each such term and condition of the IP Agreement and each such representation and warranty of Assignor contained therein, as amended hereby, shall be effective as to each item of intellectual property set forth on Exhibit A attached hereto as of the date set forth with respect to each such item. This Amendment is an integral part of the IP Agreement, effective as to each item of intellectual property set forth on Exhibit A attached hereto as of the date set forth with respect to each such item.

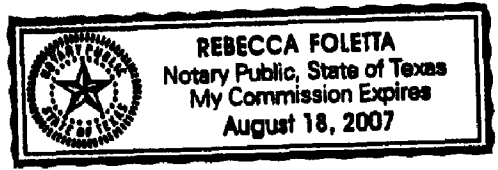
