BETWEEN:

- (1) THE ROYAL BANK OF SCOTLAND PLC in its capacity as security agent of the other Finance Parties (the "Security Agent"); and
- (2) THE COMPANIES LISTED IN SCHEDULE 1 (each a "Company" and together the "Companies").

RECITALS

- (A) By a debenture dated 21 December 2004 (the "Debenture") each Company charged all of its assets and undertaking to the Security Agent for the payment and discharge of all monies, obligations and liabilities thereby covenanted to be paid (the "Liabilities").
- (B) The Liabilities having been discharged, the Security Agent has agreed to discharge and release all the charges created by the Debenture.

THE PARTIES AGREE AS FOLLOWS:

1. RELEASE OF CHARGES

The Security Agent hereby unconditionally and irrevocably releases and discharges all of the charges and other security constituted by the Debenture.

2. RE-ASSIGNMENT

The Security Agent hereby re-assigns and re-conveys to each Company all assets and property of that Company which were assigned and/or conveyed to the Security Agent by way of security pursuant to the terms of the Debenture.

3. COSTS

Each Company shall promptly pay to the Security Agent on demand all costs and expenses (including legal fees and any value added tax or other similar tax thereon) reasonably incurred by the Bank in connection with the releases given by this deed and the preparation, negotiation and execution of this deed.

4. MISCELLANEOUS

- (a) This deed may be executed in any number of counterparts and all such counterparts taken together shall be deemed to constitute one and the same instrument.
- (b) This deed is governed by and shall be construed in accordance with English law.


