**TERMINATION OF  
TRADEMARK SECURITY INTEREST**

This Termination of Trademark Security Interest (this "Termination"), dated as of September 12, 2006, is executed by John M. Bryan, Trustee of the J.M. Bryan Family Trust ("J.M. Bryan Family Trust") in favor of The Legacy Estate Group LLC, a California limited liability company (the "Company").

**RECITALS**

WHEREAS, a certain UCC-1 Financing Statement was filed with the Secretary of State of the State of California, naming Cooperatieve Centrale Raiffeisen-Boerenleenbank B.A. ("Rabobank") as secured party, dated as of February 5, 2001 (the "UCC-1"), and a certain UCC-3 Assignment Statement was filed in connection with the UCC-1 for a full assignment from Rabobank to J.M. Bryan Family Trust, dated as of April 22, 2002; and

WHEREAS, J.M. Bryan Family Trust was listed as secured party for the UCC-1 in the records of the Secretary of State of State of California; and

WHEREAS, in connection with the UCC-1, certain trademark assignments for the security interest in a certain trademarks listed on Exhibit A (the "Trademarks") hereto were filed and recorded with the United States Patent and Trademark Office as of May 3, 2001; and

WHEREAS, the UCC-1 was terminated by J.M. Bryan Family Trust dated as of March 7, 2005; and

NOW, THEREFORE, John M. Bryan agrees as follows:

1. John M. Bryan on behalf of J.M. Bryan Family Trust is executing and delivering this Termination as further evidence of the termination of the security interest.
2. J.M. Bryan Family Trust claims in its capacity as assignee of Rabobank no right, title or interest whatsoever in or to any of the security interest in the Trademarks, and, accordingly, J.M. Bryan Family Trust expressly terminates its security interest in the Trademarks, which security interest was evidenced by the recordation of the assignment with the United States Patent and Trademark Office.
