**RELEASE OF SECURITY INTEREST IN TRADEMARKS**March 16, 2004

U.S. BANK NATIONAL ASSOCIATION, as Collateral Agent (the "Collateral Agent"), having an office at 225 Asylum Street, 23rd Floor, Hartford, CT 06103, hereby releases the security interest it holds in the trademarks and service marks of MIDAS INTERNATIONAL CORPORATION, a Delaware corporation (the "Company"), identified on Schedule A annexed hereto and all goodwill of the business associated therewith (collectively, the "Trademarks") pursuant to the Assignment for Security (Trademarks) dated March 27, 2003 between the Collateral Agent and the Company (the "Trademark Security Agreement") recorded in the United States Patent and Trademark Office on April 8, 2003 at Reel 002716, Frame 0947.

The Trademark Security Agreement was recorded solely to evidence the security interest in the Trademarks granted by the Company to the Collateral Agent. Such security interest is hereby now released. The Collateral Agent acknowledges that the description of the nature of the Trademark Security Agreement conveyance as an Assignment on the Recordation Form Cover Sheet accompanying the original filing of the Trademark Security Agreement with the United States Patent and Trademark Office was in error, and that the Trademark Security Agreement should properly have been designated as a Security Agreement. The parties never intended there to be an assignment of any ownership interest in the Trademarks under the Trademark Security Agreement or any other document, and no such assignment was ever made by the Company under the Trademark Security Agreement or any other document. Any language in the Recordation Form Cover Sheet that suggests that an assignment was made rather than a pledge of a security interest is to be regarded as scribe's error.

The Collateral Agent represents that it has submitted a corrective filing with the United States Patent and Trademark Office towards properly redesignating the Trademark Security Agreement as a Security Agreement in the United States Patent and Trademark Office records.
