HEREBY CERTIFY:

FIRST: That the Board of Directors of the Corporation, by the unanimous written consent of its members, filed with the minutes of the Board, adopted a resolution proposing and declaring advisable an amendment to the Certificate of Incorporation of the Corporation to change the name of the Corporation to "Wyndham Vacation Resorts, Inc."

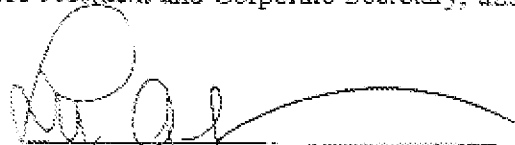
"RESOLVED, that Article FIRST of the Certificate of Incorporation be amended to read as follows:
