The Commissioner of Patents and Trademarks is requested to issue the certificate of registration for the application to register mark to said assignee.

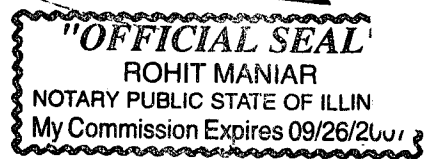
