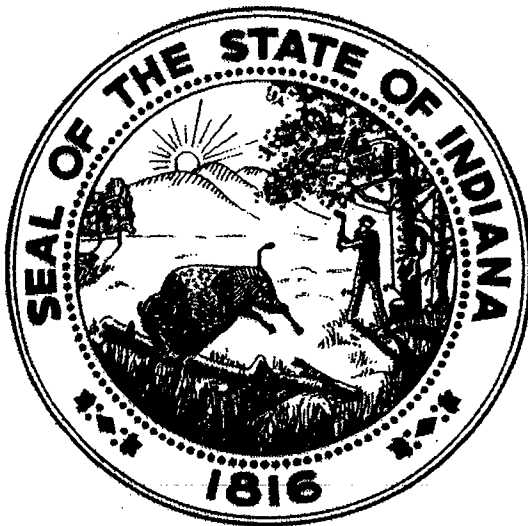

ARTICLES OF AMENDMENT  
OF  
LILLY INDUSTRIES (USA), INC.

The undersigned officer of Lilly Industries (USA), Inc. (hereinafter referred to as the "Corporation"), a corporation existing pursuant to the provisions of the Indiana Business Corporation Law, as amended (hereinafter referred to as the "Act"), desiring to give notice of corporate action effectuating amendment of its Articles of Incorporation, hereby certifies the following facts:

ARTICLE I  
Text of the Amendment

The exact text of Article I of the Articles of Incorporation of the Corporation, as amended, now is as follows (hereinafter referred to as the "Amendment"):

Name. The name of the Corporation is Valspar Industries (USA), Inc."

ARTICLE II  
Manner of Adoption and Vote

Section 1. Action by Directors. The Board of Directors of the Corporation, acting by unanimous written consent dated February 9, 2001, adopted resolutions (a) approving the Amendment, (b) directing that it be submitted to a vote of the Shareholders and (c) recommending the adoption of the Amendment.

Section 2. Action by Shareholder. The sole Shareholder of the Corporation entitled to vote in respect of the Amendment, by written consent dated February 9, 2001, adopted and approved the Amendment.

Section 3. Compliance with Legal Requirements. The manner of adoption of the Amendment and the vote by which it was adopted constitute full legal compliance with the provisions of the Act, the Articles of Incorporation and the By-Laws of the Corporation.

Section 4. Effective Date. The Amendment shall become effective when filed with the Indiana Secretary of State.

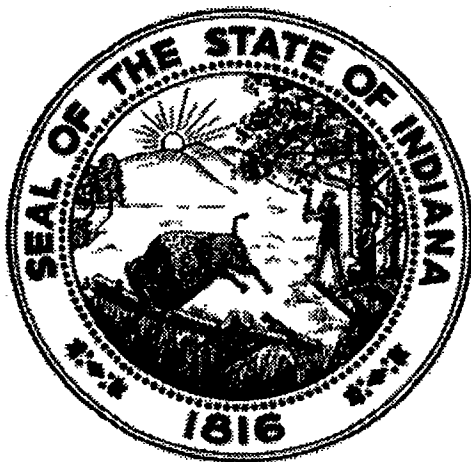
