**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release") is made as of October 23, 2006, by General Electric Capital Corporation ("Secured Party,"), in favor of Petco Animal Supplies, Inc. ("Company," successor-in-interest of Pet Food Warehouse, Inc.).

WITNESSETH:

WHEREAS, Company executed that certain SECURITY AGREEMENT (PATENT, COPYRIGHT AND TRADEMARK), dated as of May 31, 1996 ("Security Agreement"), pursuant to which Company granted a security interest to Secured Party in, among other things, certain intellectual property owned by Company; and,

WHEREAS, said Security Agreement was recorded with the United States Patent and Trademark Office on June 25, 1996, and recorded at Reel/Frame: 1480/0938 for trademarks; and,

WHEREAS, Company has satisfied its obligations under the Security Agreement; and,

WHEREAS, Secured Party has agreed to release all its rights in the collateral secured by the Security Agreement, including, without limitation, the trademarks listed on Schedule A attached hereto and covered by the Security Agreement (collectively, the "Released Collateral"), and to reconvey any and all rights it may have in the Released Collateral to Company:

NOW, THEREFORE, for good and value consideration, receipt of which is hereby acknowledged, the Parties agree as follows:

1. All security interests granted pursuant to the Security Agreement are hereby released. Secured Party hereby reconveys to Company, without recourse or warranty, all Secured Party's right, title, claim and interest in and to the Released Collateral, all proceeds thereof, all rights corresponding thereto including but not limited to all renewals, and extensions thereof, and the recordings and applications therefore.

2. This Release may be executed in two counterparts, each of which shall be deemed to be an original and all such counterparts shall constitute but one and the same instrument.
