## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

**THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY** (this "Release") is effective as of December 16, 2004 ("Effective Date") by and between HABAND COMPANY, INC., a Delaware corporation (the "Company"), HABAND ONLINE, LLC, a Delaware limited liability company ("Haband Online"), THE HABAND SURPLUS OUTLET, a New Jersey company ("Haband Surplus"), FAIRVIEW ADVERTISING, INC., a Delaware corporation ("Fairview"), HABAND OUTLET STORES IN DELAWARE, INC., a Delaware corporation ("Haband Outlet"), HABAND SURPLUS OUTLETS IN PENNSYLVANIA, INC., a Pennsylvania corporation ("Haband Surplus PA"), HABAND OAKS, LP, a New Jersey limited partnership ("Haband Oaks"), HABAND PA, LP, a Delaware limited partnership ("Haband PA"), HABAND OPERATIONS, LLC, a Delaware limited liability company ("Haband Operations"), and HABAND OVERSEAS, INC., a New Jersey corporation ("Haband Overseas") and collectively with Holdings, the Company, Haband Online, Haband Surplus, Fairview, Haband Outlet, Haband Surplus PA, Haband Oaks, Haband PA, Haband Operations, and Haband Overseas, each a "Grantor" and, collectively, the "Grantors"), and GE Business Capital Corporation (formerly known as Transamerica Business Capital Corporation ("Grantee").

**WHEREAS**, pursuant to the terms and conditions of that certain INTELLECTUAL PROPERTY SECURITY AGREEMENT by and among the Grantors and the Grantee dated as of January 28, 2002 (the "IP Security Agreement"), each Grantor granted to Grantee for its benefit and for the ratable benefit of the Lenders (as such term is defined in the IP Security Agreement), a security interest in and to all of Grantor's right, title and interest in the United States and throughout the world in, to and under all of the Intellectual Property Collateral (as such term is defined in the IP Security Agreement), including, but not limited to, that described on Schedule A attached hereto;

**WHEREAS**, the IP Security agreement was recorded with the United States Patent and Trademark Office ("PTO") on January 31, 2002 starting at Reel 002433, Frame 0068; and

**WHEREAS**, the obligations secured thereby have been paid in full.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the IP Security Agreement and terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral (as such term is defined in the IP Security Agreement).

Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Intellectual Property Collateral (as such term is defined in the IP Security Agreement); and (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register the foregoing, or any trade name or assumed name, other than those of the foregoing described on Schedule A (attached hereto), in any jurisdiction throughout the world.

Grantee shall take all further actions, and provide to Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Release.
