TRADEMARK ASSIGNMENT AGREEMENT



NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for valuable and legally sufficient consideration, the receipt and legal sufficiency of which are hereby acknowledged by SLK, Goldman Sachs accepts and SLK has sold, assigned, and transferred, and by these presents does sell, assign, and transfer to Goldman Sachs *nunc pro tunc* as of November 1, 2000, SLK's entire right, title and interest in and to the Marks, including but not limited to the registrations and applications therefor identified in Schedule A attached to this Assignment, including the right to bring actions for infringements of the Marks occurring prior to the date of this Assignment, together with that part of the goodwill of SLK's business connected with and symbolized by the Marks.
