TRADEMARK ASSIGNMENT

This assignment includes the right to use and recover damages or obtain injunctive relief for past and future infringement, misappropriation, or violation of Assignor's rights in the Marks and to bring any proceeding in the United States Patent and Trademark Office or any equivalent agency in the United States or any other country for cancellation or opposition or other proceeding in connection with said Marks. The right, title and interest is to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as it would have been held and enjoyed by Assignor had this assignment not been made.


