AMENDMENT TO  
INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT is made and entered into as of September 26, 2006, by and among U.S. CORRUGATED, INC. (f/k/a LIN PAC, INC.), a Georgia corporation ("Grantor"), in favor of CRYSTAL CAPITAL FUND, L.P., a Delaware limited partnership, in its capacity as agent (in such capacity, the "Agent") for the Lenders under the Credit Agreement hereinafter defined.

WITNESSETH:

WHEREAS, Grantor and Agent are parties to that certain Intellectual Property Security Agreement, dated as of August 31, 2006 (as amended, restated, supplemented or otherwise modified, the "IP Security Agreement"; capitalized terms used herein and not otherwise defined herein shall have the meanings given to such terms in the IP Security Agreement), wherein Grantor granted a Security Interest in the Intellectual Property Collateral; and

NOW THEREFORE, in consideration of the premises and mutual covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

The parties hereby acknowledge and agree that the name of the Grantor has been amended from "Lin Pac, Inc." to "U.S. Corrugated, Inc." Attached hereto as Exhibit A is the charter from the Secretary of State from the State of Georgia evidencing such name change from "Lin Pac, Inc." to "U.S. Corrugated, Inc."

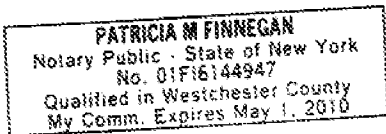
