**TRADEMARK ASSIGNMENT AGREEMENT**

WHEREAS Industrie Bodco Inc. (the “**Assignor**”), a Canadian corporation, is the owner of those trademarks (the “**Marks**”) listed on the attached Schedule A, together with those registration (the “**Registrations**”) therefor listed on the Schedule A; and

WHEREAS pursuant to a judgment rendered on October 30, 2006 by Pierre C. Fournier, a judge of the Superior Court of the Province of Quebec, in the court file number 450-11-000166-066, Raymond Chabot Inc., in its quality as interim receiver to the assets of the Assignor (the “**Interim Receiver**”), has been duly authorized to sign, execute and deliver for and on behalf of the Assignor, the *Convention de vente d'actifs* hereinafter referred to; and

WHEREAS Équipements de ferme Jamesway Inc. (the “**Assignee**”), a Company of the Province of Quebec, Canada, wishes to acquire the Marks and the Registrations, together with the goodwill of the business in connection with which the marks are used; and

WHEREAS pursuant to an asset purchase agreement entitled *Convention de vente d'actifs* entered into between Assignor and Assignee on October 31, 2006 (the “**Agreement**”), Assignor has agreed to sell to Assignee all right, title and interest in the Marks and Registrations; and


WHEREAS the parties wish to memorialize the assignment of the Marks and Registrations by a separate Trademark Assignment Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which Assignor hereby acknowledges, Assignor hereby agrees to and does sell, assign and transfer to Assignee its entire right, title and interest in and to the Marks and the Registrations, together with the goodwill of the business to which the Marks pertain, as well as all rights of enforcement and recovery for past infringement.
