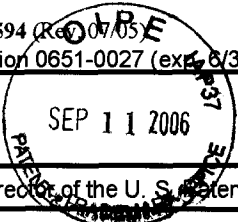


CONFIRMATORY ASSIGNMENT


