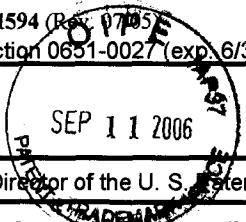

THIS RELEASE is made as of this 4th day of November, 2005, by **Merrill**


