**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF
STEPHEN A. HALL ENTERPRISES, L.L.C.**

Pursuant to the provisions of Article 3.05 of the Texas Limited Liability Company Act, the undersigned hereby certifies as follows:
