ASSIGNMENT

TII has assigned, and transferred, and by these presents, TII hereby does assign, transfer, and deliver to Ransomes Rhode Island, its successors, assigns, and legal representatives the whole of any and whatever right, title, and interest TII may have in and to: (i) the trademarks listed in Exhibit A hereto, and any United States, state or foreign registrations of such trademarks, applications filed, common-law rights related to said trademarks, rights to obtain renewals and all other legal protections pertaining thereto (hereinafter, the "Trademarks"); and (ii) the goodwill of TII's business symbolized by and associated with the trademarks listed in Exhibit A hereto (hereinafter, the "Goodwill").


2. FURTHER ASSURANCES


