INTELLECTUAL PROPERTY RELEASE

WHEREAS, KRB Seed Company, LLC (“KRB”) executed and delivered to ABT GROUP, LLC (the “Lender”) a Security Agreement in favor of the Lender, dated July 18, 2000 (the “Security Agreement”), recorded in the records of the United States Patent and Trademark Office (the “PTO”), Reel/Frame 002119/0855, and recorded in the records of the United States Department of Agriculture, Plant Variety Protection Office (the “PVPO”), effective July 25, 2000, encumbering among other things, (i) those certain trademarks set forth on the attached **Exhibit A**, which are registered on the Principal Register of the PTO, under the registration numbers set forth opposite each trademark; and (ii) those certain plant varieties set forth on the attached **Exhibit B**, which are registered with the PVPO under the certificate numbers set forth opposite each plant variety (collectively, the “Collateral”).

WHEREAS, pursuant to the terms of that certain Collateral Substitution Agreement, dated May 14, 2004, Lender and KRB have terminated the Security Agreement and Lender has released its security interest in and to the Collateral.

NOW, THEREFORE, for and in consideration of the sum of TEN AND NO/100 DOLLARS (\$10.00), and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender does hereby release and forever discharge and quitclaim from all liens, including the lien of the Security Agreement, all right, title, and interest of the Lender in and to the Collateral.

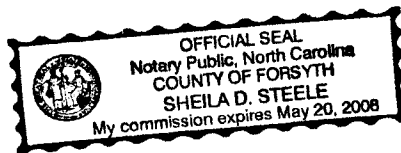
