## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of November 2, 2006, by **THE ROYAL BANK OF SCOTLAND PLC**, as the First Lien Collateral Agent and the Second Lien Collateral Agent ("**Bank**").

### WITNESSETH:

WHEREAS, Bank, Osmegen Incorporated, a Pennsylvania corporation ("**Osmegen**"), Bix Enterprises, Inc., a Delaware corporation ("**Bix**") and Site-B Company, a Washington corporation ("**Site-B**", together with Osmegen and Bix, the "**Grantor**"), were parties to that certain Trademark Security Agreement dated as of November 30, 2004 (the "**Assignment**"), pursuant to which Grantor granted a security interest to Bank in certain trademarks and trademark licenses (the "**Secured Trademarks**") as security for certain obligations owing by Grantor to Bank, including the Secured Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on December 8, 2004, at Reel 3089, Frame 0536; and

WHEREAS, Grantor has requested that Bank release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Secured Trademarks and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Bank hereby releases its security interest in and lien on all of Grantor's right, title and interest in, to and under the following Secured Trademarks:

(i) each trademark and application for trademark listed on Schedule I annexed hereto, together with any reissues, continuations or extensions thereof; and

(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future infringement of any trademark.

2. Bank hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Bank, all of Bank's right, title and interest in and to the Secured Trademarks.
