**DECLARATION CONCERNING CHANGE OF NAME**

1. My name is Conrad M. Hall. I am the President and C.E.O. of Dominion Enterprises. This Declaration is submitted as evidence of the change of name of Trader Publishing Company to Dominion Enterprises.

2. Trader Publishing Company was created on or about March 31, 1991 as a joint venture by LTM Company, L.P., a Virginia limited partnership ("LTM Company"), successor to LTM Company, a Virginia general partnership, and Cox Auto Trader, Inc., a Delaware corporation formerly known as TPI, Inc. ("CAT").

3. On September 10, 2006, as part of a significant restructuring effort of Trader Publishing Company, an Amended and Restated Joint Venture Agreement was entered into, which, among other things, changed the name of Trader Publishing Company to Dominion Enterprises.

4. Dominion Enterprises seeks the recordal of this name change against the registrations and applications attached as Exhibit A hereto.

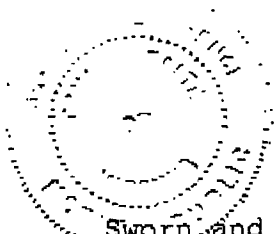
