RELEASE OF SECURITY INTEREST ON TRADEMARKS

This Release of Security Interest on Trademarks (the "Release"), dated as of October 30, 2006, is made by General Electric Capital Corporation ("GECC"), and relates to the Released Trademarks (as herein defined) in which GECC was granted a security interest by Reeves Brothers, Inc. (the "Company") in connection with a Credit Agreement, dated as of November 6, 1997 as amended by the Amended and Restated Credit Agreement, dated as of October 30, 2002 and pursuant to the Security Agreement and the Trademark Security Agreement, dated as of November 6, 1997 and the Second Amended Security Agreement, dated as of October 30, 2002 (including all annexes, exhibits or schedules thereto), by and among GECC and the Company and other persons listed therein as grantors, (altogether the "Security Agreement").

WITNESSETH:

WHEREAS, GECC and the Company entered into the Security Agreement, pursuant to which the Company granted a security interest to GECC in certain trademarks and trademark applications, including the trademarks listed in Schedule A, annexed hereto and made a part hereof (the "Released Trademarks") to secure the performance of certain obligations (the "Obligations") and;

WHEREAS, the Obligations (other than contingent obligations that expressly survive the termination of the Credit Agreement) have now been satisfied, the Company has requested that GECC release any and all interest it may have in the Released Trademarks, and GECC has agreed to do so.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, GECC does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.

IN WITNESS WHEREOF, GECC has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the date hereinabove set forth.
