**RELEASE OF SECURITY AGREEMENT IN TRADEMARKS**

**THIS RELEASE OF SECURITY AGREEMENT IN TRADEMARKS** (this "Release") is made as of November 24, 2003 ("Effective Date") by and between Ableco Finance LLC ("Assignee") and TCF Railco Information Systems Corp. ("Assignor").

**WHEREAS**, pursuant to the terms and conditions of that certain Security Agreement between Assignor and Assignee dated January 14, 2002 (the "Security Agreement"), Assignor granted to Assignee a security interest in and to all of Assignor's right, title and interest in and to the Trademarks set forth on Schedule A attached hereto, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the trademarks (collectively, the "Trademarks");

**WHEREAS**, the Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on February 12, 2002, at Reel 2450, Frame 0966; and

**WHEREAS**, Assignor has paid all of its outstanding indebtedness to Assignee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee hereby terminates the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks, without recourse and without any representation or warranty of any kind, express or implied.

Assignee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; and (iii) it has not recorded or otherwise evidenced its security interest with respect to the Trademarks, in any non-U.S. jurisdiction.

Assignee shall, at Assignor's expense, take all further actions, and provide to Assignor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Assignor to more fully and effectively effectuate the purposes of this Release.
