Videojet Systems International, Inc., a corporation organized and existing under the laws of the State of Delaware (the "Corporation"),

DOES HEREBY CERTIFY:

FIRST: That this Corporation was incorporated on the fourteenth day of April, 1966, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That this Corporation owns all of the outstanding shares of the capital stock of:

- (1) Marconi Data Systems Inc., a corporation incorporated on the twenty-second day of June, 1999, pursuant to the General Corporation Law of the State of Delaware; and
- (2) Marsh Company, a corporation incorporated on twenty-first day of December, 1920, pursuant to an Act of the General Assembly of the State of Illinois entitled "An Act in relation to corporations for pecuniary profit" (now the Illinois Business Corporation Act of 1983).

THIRD: That this Corporation, by the following resolutions of its Board of Directors, duly adopted by the written consent of its members, filed with the minutes of the Board, on the eighth day of December, 1999, determined to and did merge into itself said Marconi Data Systems Inc. and said Marsh Company:

"RESOLVED: That Videojet Systems International, Inc. merge, and it hereby does merge into itself said Marconi Data Systems Inc. and said Marsh Company and assume all of their liabilities and obligations.

FURTHER RESOLVED: That the merger shall be effective on January 1, 2000 at 12:01 a.m. (the "Effective Time").

FURTHER RESOLVED: That the proper officer of this Corporation be and he hereby is directed to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge said Marconi Data Systems Inc. and said Marsh Company and assume their liabilities and obligations, and the date of adoption thereof, and to cause the same to be filed with the Secretary of State of Delaware and to do all acts and things whatsoever, whether within or without the State of Delaware, which may be necessary or proper to effect said merger.

FURTHER RESOLVED: That at the Effective Time, this Corporation change its corporate name by changing Article FIRST of its Certificate of Incorporation to read in its entirety as follows:

'FIRST. The name of the corporation is Marconi Data Systems Inc.'
