**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of October 30, 2006, is made by Wachovia Bank, National Association, as Collateral Agent ("Wachovia"), in favor of GAKM Resources Corporation ("GAKM") as follows:

**WITNESSETH**





