## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** is made as of June 2, 2006 (the “**Effective Date**”) by and between Mills Biopharmaceuticals, Inc. (“**Assignor**”) and Coloplast A/S, a corporation of Denmark, having a place of business at Holtedam 1, 3050 Humlebaek, Copenhagen, Denmark (“**Assignee**”).

### WITNESSETH:

**WHEREAS**, Mentor Corporation, a Minnesota corporation (“**Mentor**”) and Assignee entered into a Purchase Agreement (the “**Purchase Agreement**”), dated as of May 17, 2006, providing for the purchase by Assignee from Mentor of certain assets (the “**Transferred Assets**”) of Mentor’s urology business (the “**Business**”); and

**WHEREAS**, the trademarks, trademark registrations and trademark applications listed in Attachment A (“**Trademarks**”) are included in the Transferred Assets to be transferred by Assignor to Assignee pursuant to the Purchase Agreement and this Trademark Assignment.


**NOW, THEREFORE**, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, effective as of the Effective Date:

1. Assignor hereby irrevocably assigns, transfers and sells, and confirms the assignment, transfer and sale, to Assignee all of Assignor's rights, title and interest in and to the Trademarks throughout the world, together with the goodwill of the Business symbolized by the Trademarks, including the right to pursue and recover past and future damages from third-party infringers of the such Trademarks.
2. In the event that additional assignment documents are required to accomplish or record the assignment to Assignee of the Trademarks in any other country or jurisdiction, Assignor hereby agrees, without further consideration, to execute and deliver such assignments to Assignee.
3. Assignee shall have the right to, and shall be solely responsible for, filing or recording this Trademark Assignment, and any additional assignment documents as provided in Paragraph 2 above, with the United States Patent and Trademark Office and any other equivalent authority anywhere else in the world.
4. This Trademark Assignment shall be deemed to have been made in, and shall be construed pursuant to the laws of the State of Minnesota and the United States of America without regard to conflicts of laws provisions thereof.

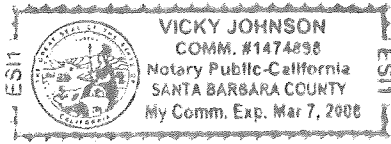
