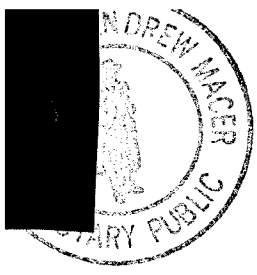

TRADEMARK ASSIGNMENT


