
**DECLARATION IDENTIFYING CORRECT OWNER**

**NOTIFICATION OF ERRONEOUS RECORDED ASSIGNMENT**

The correct owner of Reg. No. 2,784,094 has been and continues to be KLS-Martin L.P., a Delaware partnership, the original registrant as indicated on the registration certificate. The owner has not transferred any rights in the mark or registration to any third party.

It has been discovered that an assignment recorded at reel/frame 2961/0464 on 10/21/2004 was submitted with erroneous information, as it purports to show assignment of this registration from Cannery Casino Resorts, LLC to the CIT Group/Equipment Financing, Inc. Cannery Casino Resorts, LLC, has never had any ownership interest in Reg. No. 2,784,094. It is presumed that Cannery Casino Resorts, LLC, intended to transfer its Reg. No. 2,764,094, but incorrectly typed the number on its cover sheet (and possibly in the security agreement itself). The chain of title for this registration should not be considered altered by the incorrect assignment recorded at reel/frame 2961/0464.


