WHEREAS, Assignor desires to assign all its right, title, and interest in any and all of the Marks;



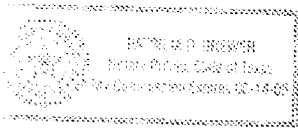
