Pursuant to Section 252 of the
 General Corporation Law
 of the State of Delaware

Wired Digital, Inc., a Delaware corporation and wholly owned subsidiary of Wired Ventures, Inc., a Delaware corporation and a wholly owned subsidiary of Lycos, Inc., a Virginia corporation ("Lycos"), hereby certifies the following information relating to the merger of GetRelevant, a California corporation (the "Merger"):

1. The name and state of incorporation of the constituent corporations are: (a) GetRelevant, a corporation organized and existing under the laws of the State of California ("GetRelevant") and a wholly owned subsidiary of Lycos, and (b) Wired Digital Inc., a corporation organized and existing under the laws of the State of Delaware ("Wired Digital") (collectively the "Constituent Corporations").
2. An Agreement and Plan of Merger, dated as of June 3, 2003, between GetRelevant and Wired Digital (the "Merger Agreement"), was approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations in accordance with Section 252 of the General Corporation Law of the State of Delaware.
3. Upon consummation of the Merger, the surviving corporation will be Wired Digital.
4. The Certificate of Incorporation of Wired Digital shall be the certificate of incorporation of the surviving corporation without any amendment thereto contemplated hereby.
5. The executed Merger Agreement is on file at the principal place of business of the surviving corporation, at 100 Fifth Avenue, Waltham, MA 02451.
6. A copy of the Merger Agreement will be furnished by the surviving corporation upon request and without cost to any stockholder of either of the Constituent Corporations.
7. The authorized capital stock of GetRelevant is 1,000 shares of common stock, of which 100 shares are issued and outstanding.
8. The effective date of the Merger shall be the date on which this Certificate of Merger is filed with the Secretary of State of the State of Delaware.


