ASSIGNMENT OF SERVICE MARK

WHEREAS, Entravision Communications Corporation, a corporation organized and existing under the laws of the State of Delaware ("Assignor"), is the owner of all right, title and interest in and to the service mark (the "Mark") set forth in **Schedule A**, attached hereto; and

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor, by these presents, does hereby sell, assign, transfer and set over, unto the Assignee, its successors, legal representatives and assigns, its entire right, title and interest in and to the Mark together with the goodwill of the business associated therewith, and all claims for damages by reason of past, present and future infringement of the rights assigned under this Assignment with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives; the above transferred right, title and interest to be held and enjoyed by said Assignee, its successors, legal representatives and assigns as fully and entirely as the same would have been held and enjoyed by the Assignor had this assignment not been made;

THE PARTIES HEREBY agree that notwithstanding any representation or covenant made by Assignor in this instrument, no claim shall arise as between Assignee and Assignor hereunder. Any claims with respect to the Mark shall arise solely under and shall be subject to such limitations applicable to, including, in each case, the indemnification provisions and limitations thereon set forth in, that certain Asset Purchase Agreement, dated as of August 2, 2006, by and between Assignor, Assignee and the other parties thereto, as amended.

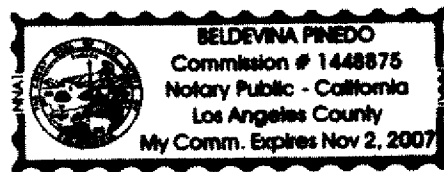
