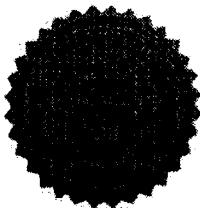


"FIRST. The name of the limited liability company is TSY'S Acquiring Solutions, L.L.C."
