RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT is made this 13th day of November, 2006, by Wachovia Bank, National Association, formerly known as Congress Financial Corporation (Southwest), located at 5001 LBJ Freeway, Suite 1050, Dallas, Texas 75244 ("Secured Party"), in favor of, Sport Supply Group, Inc., a Delaware corporation located at 1901 Diplomat Drive, Farmers Branch, TX 75234 ("Debtor").
