**RELEASE OF SECURITY INTEREST -- TRADEMARKS**

WHEREAS, ABN AMRO BANK, N.V., NEW YORK BRANCH, FLEET PRECIOUS METALS, INC., CREDIT SUISSE FIRST BOSTON, and PARIBAS, MITSUI & CO. (U.S.A. INC.) as "Consignors", BANK OF AMERICA, N.A.
