RELEASE OF SECURITY INTEREST
IN TRADEMARKS

UNIVERSAL CONCERT COMPANY, a Colorado general partnership (now known as HOB CONCERTS COMPANY) ("Grantor"), executed a Security Agreement dated as of September 10, 1999 in favor of BANK OF AMERICA, NATIONAL ASSOCIATION, as Administrative Agent and Collateral Agent ("Agent") for the lenders party to that certain Credit Agreement dated as of September 10, 1999, among HOB Entertainment, Inc., the lenders named therein, and Agent. The Security Agreement was recorded in the United States Patent and Trademark Office on September 28, 2000 at Reel 002160, Frame 0224. Pursuant to the Security Agreement Grantor assigned and granted to Agent a security interest in and to all of Grantor's right, title and interest in and to its trademarks and trademark applications, including the trademarks listed on Exhibit A attached hereto (the "Marks") and the goodwill associated therewith.

Agent wishes to release, retransfer and reassign to Grantor, without representation or warranty, all of Agent's right, title and interest in and to the Marks and the goodwill associated therewith.

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself, its successors, legal representatives and assigns, hereby releases, retransfers and reassigns to Grantor, without representation or warranty of any kind, express or implied, all of Agent's right, title and interest in and to the Marks and the goodwill associated therewith.
