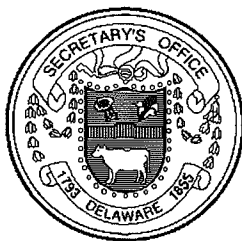

The undersigned, on behalf of GT Equipment Technologies, Inc., a corporation duly organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), DOES HEREBY CERTIFY as follows:

FIRST: That at a meeting of the Board of Directors of the Corporation resolutions were duly adopted setting forth a proposed amendment of the Certificate of Incorporation of said corporation, declaring said amendment to be advisable and calling a meeting of the sole stockholder of said corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Certificate of Incorporation of GT Equipment Technologies, Inc., a Delaware corporation, be amended by changing the Article thereof numbered "ONE" so that, as amended, said Article ONE shall be read as follows:

The name of the corporation is GT Solar Incorporated

SECOND: That thereafter, pursuant to resolution of its Board of Directors, in accordance with Sections 228 and 242 of the General Corporation Law of the State of Delaware, the amendment to the Certificate of Incorporation was duly approved and adopted pursuant to a written consent signed by the holders of all the issued and outstanding shares of capital stock entitled to vote thereon.
