TRADEMARK ASSIGNMENT OF SECURITY

WHEREAS, REDCATS USA, L.P., formerly known as Brylane, L.P., a limited partnership formed under the laws of Delaware, located at 463 Seventh Avenue, New York, New York 10018, ("Borrower"), has adopted, used and is using the marks shown in the attached Schedule A (the "Trademarks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, Borrower is obligated to BANK OF AMERICA, N.A. ("BoFA") and various other financial institutions (collectively, "Lenders") and BoFA as administrative and collateral agent for Lenders ("Agent") pursuant to (i) a certain Amended and Restated Credit Agreement, dated as of the date hereof, among Agent, Lenders, Borrower, Chadwick's of Boston, Inc. and Redcats USA, Inc., and (ii) a certain Trademark Collateral Security Agreement, dated as of December 10, 2003, made by Borrower in favor of Agent (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements"); and




