NOW, THEREFORE, for one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor does hereby assign unto the Assignee all right, title and interest in and to the Assigned Trademarks, together with the goodwill of the business symbolized by the Assigned Trademarks and the associated registrations and applications therefor and all causes of action, rights of recovery and claims for damages and other relief referring, or pertaining to the Assigned Trademarks including claims for past and future infringement.

The Assignor shall promptly render all assistance reasonably necessary to record the Assignee as the owner of the Assigned Trademarks. Assignor shall, upon reasonable notice, provide to Assignee or its legal representative further documents and information which may be required from time to time in connection with the renewal, prosecution or enforcement of the Assigned Trademarks.

Assignor shall transfer to Assignee or its legal representatives all original files and documents relating to the Assigned Trademarks, including but not limited to, all application and registration files for the Assigned Trademarks, certificates of registration, and search reports and opinions concerning availability and registrability for the Assigned Trademarks.
