RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, MPC Computers, LLC, a Delaware limited liability company ("Debtor") granted a security interest in and lien upon certain trademarks and related rights to Wachovia Capital Finance Corporation (Western), as Agent ("Secured Party") as set forth in the Trademark Collateral Assignment and Security Agreement, dated as of July 8, 2005 between Debtor and Secured Party (the "Trademark Security Agreement");

1. releases and reassigns to Debtor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Trademark Collateral Assignment and Security Agreement in the trademarks more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Debtor to Secured Party pursuant to or in connection with the Trademark Collateral Assignment and Security Agreement is terminated; and
3. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.



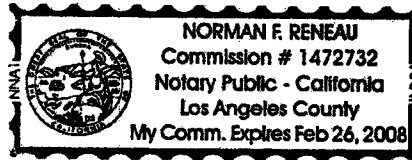
