## ASSIGNMENT OF TRADEMARKS

WHEREAS, KIDPOWER, INC., a Tennessee corporation having its principal place of business at 8005 Church Street East, Brentwood, Tennessee 37027 (the "Seller") is the owner of record of the name "Soakasaurus" including without limitation those trademarks, trademark registrations and trademark applications therefore listed on Exhibit A annexed hereto (collectively, the "Trademarks") and the goodwill appurtenant thereto; and

WHEREAS, SUN MASTER INVESTMENT LIMITED, a corporation organized under the laws of the Hong Kong Special Administrative Region of the Peoples' Republic of China, having its principal place of business at 125 E. Bethpage Road, Plainview, New York 11803 (the "Buyer") desires to acquire the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Seller does hereby sell, assign and transfer unto the Buyer and the Buyer does hereby purchase from the Seller all of the Seller's entire right, title and interest throughout the world, under any federal or state law or regulation, under common law or otherwise in and to the Trademarks together with the goodwill appurtenant thereto and to the business in connection with which the Trademarks are used (including without limitation the registration thereof which are listed on Exhibit A annexed hereto and the related goodwill) and the Seller's right, title and interest in and to any and all claims and demands it may have either at law or in equity arising out of past, present or future infringement or use of the foregoing.

The Seller hereby authorizes appropriate officials to record this instrument and to record the Buyer as the new owner of the Trademarks. This Assignment is being executed and delivered pursuant to and is subject to the terms and provisions of the Asset Purchase Agreement between Buyer and Seller of even date herewith.
