## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("*Assignment*"), dated as of November 20, 2006 (the "*Effective Date*") is between 101 ACQUISITION, INC., a Delaware corporation (the "*Assignee*"), on the one hand, and REEBOK INTERNATIONAL LTD., a Massachusetts corporation ("*Assignor*").

WHEREAS, Assignor and Assignee are parties to the Asset Purchase Agreement, dated as of October 24, 2006 ("*Asset Purchase Agreement*"), among MacGregor Golf Company, a Delaware corporation, Assignee, Assignor, and the other Sellers (as defined therein), pursuant to Section 1.5(c) of which, execution and delivery of this Assignment is required at the Closing (as defined in the Asset Purchase Agreement);

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in and to the Trademarks that are Assigned IP Assets under the Asset Purchase Agreement, including without limitation those listed on Schedule A hereto, together with the goodwill of the business connected with the use thereof and symbolized thereby, the registrations and applications for registration thereof and rights of renewal and extension thereof, all income, royalties, damages and payments now or hereafter due or payable with respect thereto, all common-law rights related thereto and all causes of action and rights of recovery for, and all claims for damages by reason of, past, present and future infringements, dilutions or violations of the foregoing, and the right to bring any proceeding in the United States Patent and Trademark Office or any equivalent agency in any other country for cancellation, opposition or otherwise in connection with the trademarks (the foregoing, collectively, the "*Assigned Trademarks*").
2. Each party warrants that (i) this Assignment is a legal, valid and binding obligation of the warranting party, and (ii) it has full power and authority to enter into and perform its obligations under this Assignment in accordance with its terms. The Assigned Trademarks are assigned solely on an "as is" basis.
3. The right, title and interest in and to each of the Assigned Trademarks is to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as it would have been held and enjoyed by Assignor had this assignment not been made.
4. Assignor will, without additional consideration, take such further actions and execute promptly such further documents as are necessary to effect and record the assignment herein, including any actions or documents that may be necessary to protect, secure and vest good, valid and marketable title to the Assigned Trademarks in Assignee.

5. Assignor hereby authorizes Assignee to request the relevant government entity or agency, in each applicable country or jurisdiction, to record Assignee as the assignee and owner of the Assigned Trademarks.

6. This Assignment may be executed in one or more counterparts, all of which shall be considered one and the same agreement, and shall become effective when one or more such counterparts have been signed by each of the parties and delivered to the other party.

7. This Assignment shall be governed and construed in accordance with the laws of the State of Delaware.
