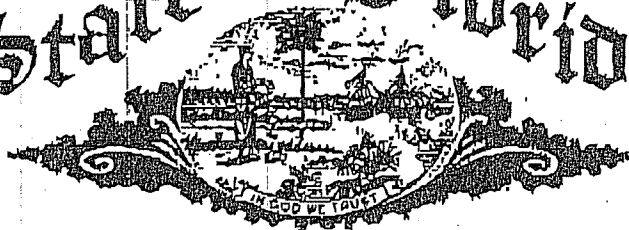

Pursuant to Section 607.1101, 607.1103, 607.1105 and 607.1109 of the Florida Business Corporation Act (the "FBCA"), Intradeco Apparel, Inc., a Florida corporation ("Intradeco Apparel") and Wright's LLC, a Delaware limited liability company ("Wright's") adopted on the 29 day of August, 2003, the following Articles of Merger for the purpose of effecting a merger in accordance with the provisions of the FBCA and hereby certify as follows:

ARTICLE I

The Agreement and Plan of Merger (the "Plan of Merger"), attached hereto and incorporated by reference herein, and adopted by approved in accordance with the provisions of Section 607.1103 of the FBCA, provides for the merger of Wright's with and into Intradeco Apparel, with Intradeco Apparel as the surviving corporation (the "Merger").

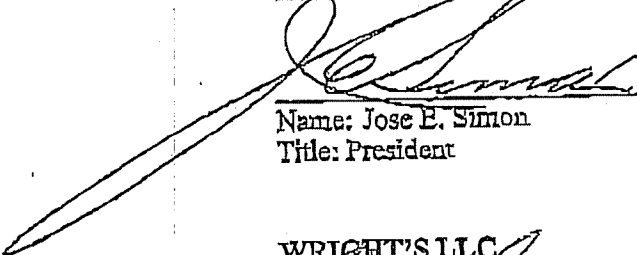

ARTICLE IV

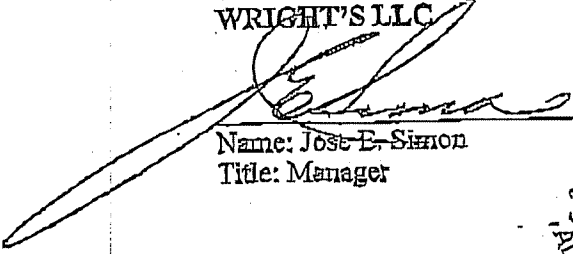
