RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST ("Release"), effective as of November 22, 2006 (the "Effective Date"), is between Intrexon Corporation, a Virginia corporation ("Intrexon"), and NewVa Capital Partners, LP, a Virginia limited partnership ("NewVa").

WHEREAS, pursuant to that certain Security Agreement, dated February 28, 2006, between Intrexon and NewVa (the "Security Agreement"), and that certain Trademark Security Agreement, dated February 28, 2006, between Intrexon and NewVa (the "Trademark Security Agreement"), Intrexon has granted to NewVa a security interest in certain collateral to secure that certain Secured Convertible Promissory Note referred to in the Security Agreement and Trademark Security Agreement, including certain Trademarks, as defined in the Security Agreement and Trademark Security Agreement;

WHEREAS, the security interest in the Trademarks was recorded with the United States Patent & Trademark Office ("PTO"), on May 17, 2006, at Reel/Frame numbers 003310/0886; and

WHEREAS, in consideration of Intrexon's fulfillment and discharge of its obligations to NewVa under the Secured Convertible Promissory Note, NewVa is willing to release the security interest in the Trademarks;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Release of Security Interest. NewVa hereby releases the security interest that Intrexon granted to NewVa in the Trademarks, and NewVa reassigns to Intrexon all right, title, and interest that NewVa may have in the Trademarks.
2. Recordation of Release. NewVa authorizes the recordation of this Release with the PTO. NewVa notes that, of the six (6) applications filed with the PTO for registration of the Trademarks, five (5) of those applications are now abandoned according to PTO records (Application Serial Nos. 78/340,900, 78/370,700, 78/560,490, 78/582,467, and 78/634,847).

IN WITNESS WHEREOF, the parties have caused this Release to be executed by their duly authorized representatives, effective as of the Effective Date.
