**RELEASE OF  
SECURITY INTEREST IN TRADEMARK RIGHTS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS** ("Release") is given as of this \_\_\_ day of August, 2006 by United Properties Holdings Ltd., a Bahamas corporation, as agent (in such capacity, "Agent") for lenders ("Lenders") from time to time party to that certain Loan Agreement (as hereinafter defined), in favor of Fawkes Travel, Inc., a Massachusetts corporation, located at 55 Court Street, Boston, Massachusetts 02108 ("Fawkes").

**WHEREAS**, Fawkes, Agent and Lenders entered into that certain Loan and Security Agreement dated as of December 4, 2003 (as amended from time to time, the "Loan Agreement"), pursuant to which Lenders agreed to make advances of money and to extend certain financial accommodations to Fawkes;

**WHEREAS**, pursuant to the Loan Agreement, Fawkes and Agent entered into that certain Trademark Security Agreement, made as of December 4, 2003, pursuant to which Fawkes granted a security interest in all of it's right, title and interest in the trademarks set forth on Schedule A attached hereto (the "Trademarks"), to Agent, for its benefit and the benefit of the Lenders, which security interest was recorded in the United States Patent and Trademark Office on December 5, 2003 at Reel 2758/Frame 0851;

**WHEREAS**, Agent desires to terminate its security interest in all right, title or interest in and to the Trademarks;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby releases its security in all right, title or interest in and to the Trademarks and reassigns any and all right, title and interest that it may have in the Trademarks to Fawkes.
