
WHEREAS, as part of the Acquisition, MWV is desirous of acquiring the entire right, title and interest in and to the SGC Trademarks,

3. SGC further agrees that, upon the request of MWV, it will sign all papers, make all rightful oaths, and perform all acts that MWV may reasonably believe to be necessary in connection with the assignment made herein and the SGC Trademarks.
