This RECORDATION FORM OF TRADE NAME AND SERVICE MARK ASSIGNMENT (this "Assignment") is entered into as of the date of last signature below by and between Sheldon Evans, an individual ("Assignor"), as assignor, in favor of Cliff Petrovsky, an individual ("Assignee"), as assignee, with reference to the following facts and circumstances:

WHEREAS, Assignor is the owner of the trade name and service mark THE TAX ADVANTAGE for income tax preparation services and U.S. Reg. No. 1,714,083 (App. No. 74/222,063) for the mark THE TAX ADVANTAGE for income tax preparation services (all of the aforementioned rights shall hereafter be collectively referred to as the "Trademark").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign and transfer unto Assignee all right, title and interest of Assignor in and to the Trademark, together with the goodwill of the business symbolized by the Trademark, as well as his entire right, title and interest in and to all registrations of the Trademark heretofore granted or applied for, any and all common law rights to the Trademark in the United States and any state thereof and in any country in the world, and any and all claims and demands he may have either at law or in equity arising out of any past infringements.

If there is any conflict between this Assignment and the TRADE NAME AND SERVICE MARK ASSIGNMENT AGREEMENT, the terms of the TRADE NAME AND SERVICE MARK ASSIGNMENT AGREEMENT shall control.


