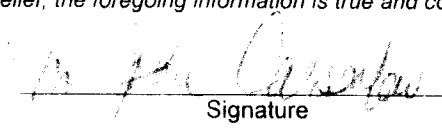

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

The undersigned certify that:

1. They are the president and the secretary, respectively, of California Commerce Bank, a California corporation (hereinafter, the "Corporation").
2. Article I of the Second Restated Articles of Incorporation ("Articles of Incorporation") of the Corporation is hereby amended and restated in its entirety as follows:

"I. The name of this corporation is Citibank (Banamex USA)."

3. The foregoing amendment of Articles of Incorporation has been duly approved by the Corporation's board of directors.
4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding shares of the corporation is 753. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
