**RELEASE OF SECURITY INTEREST

Heritage agrees to provide IPC with any information and additional authorization necessary to effect the release of Heritage's security interest in the Released Trademark Collateral.

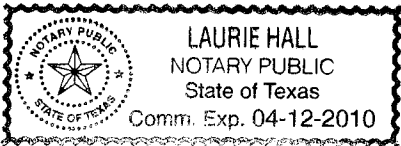
